President's Message: Happy 2006!

We had our best general members meeting in years at Tucson in February, but I still feel like I did last year when New Year resolutions roll around: I don't think either I or FM quite lived up to our potential.

Our regular projects are all still active. We didn't provide significant financial support for worthwhile causes as we did in 2004, but we did offer moral backing for a good cause with our letter to the Philadelphia Academy of Sciences urging appropriate deaccession of their important collection. Some say we may have had an impact; as far as I know the issue still hasn't been finally resolved.

The localities index project is more active than it was a few years ago, and some of our chapters have been very busy. The annual joint symposium on the Saturday of the Tucson Gem and Mineral Show has become a little shorter over the past few years, but there are some great speakers lined up to talk about Canada (see schedule in this newsletter). I do know from past experience that our annual magazine and educational case awards are much appreciated by authors/displayers, and our own FM case at the Tucson show is good publicity.

On the other hand, attempts to "rejuvenate" FM without changing its essential character have not gone far. Some good ideas turn out to be impractical. Other proposals suffer from a problem common to many "volunteer" groups: nobody to follow through.

What can you do? First and foremost,

please attend the annual meeting and social (see announcement) and give us some ideas. More importantly, jump in and work on a project for a year or two. Also at the meeting perhaps you can get ideas to take back to your chapters to boost their activities and membership.

Second, please vote and mail in the ballots in this newsletter for a minor change to our bylaws, giving us the flexibility to schedule our Tucson meetings as needed, and for FM Board members. It is an inexpensive gesture in time and money to at least send in a ballot and avoid having a shameful number of votes received. Want more choice? Volunteer to be on the board or to undertake some of our projects.

Third, attend the symposium at the Tucson show February 11th. It only lasts a couple of hours, you can come and go as you like, and you will learn something interesting and useful. The schedule appears in this newsletter and TGMS will post the location (room) at the show.

Fourth, if you display at the show, please consider an educational aspect to your case. It makes the cases much more meaningful. AND, make up a little token or sign to note you are a member of Friends of Mineralogy, citing the chapter if appropriate, for your case. We are considering a standardized label/sign/thingamabob we could get made up for members who want them.

I look forward to seeing you at the meeting!

Midwest Chapter submitted by Marlene Edington

The Field Symposium held September 24-25 was attended by 26 members and guests. Hanson Aggregates Midwest, Sylvania Quarry in northern Lucas County, Ohio, provided the best collecting of the two-day excursion. This quarry belongs to the Middle Devonian Detroit River Group. Sky blue and white to colorless bladed to tabular crystals of celestine were found. Some celestine pockets were filled with pale yellow curved calcite rhombohedra in groups several centimeters across. Rocks exposed in the Graymont

Dolime Quarry at Genoa belong to the fossiliferous Middle Silurian Lockport Dolomite. Celestine is abundant. Some sphalerite and fluorite along with iridescent pyrite and pale yellow calcite crystals were present.

John Medici's lecture on Saturday evening was on collecting celestine in northwestern Ohio and southeastern Michigan. Joe Vasichko discussed fluorescent and phosphorescent minerals in northwestern Ohio. The symposium ended on Sunday morning at MacRitchie Materials at West Millgrove.
Rocks at this site include the Middle Silurian Lockport
Dolomite and late Silurian
Greenfield Dolomite. Collecting for celestine was good and crystals were found in white to pale blue with bladed and tabular habits.

Our last meeting of the year was in conjunction with the Micromineral Symposium at the Cleveland Museum of Natural History on Nov. 5. A short business meeting was held. Election of officers for 2006 will take place at our Jan. 15 meeting.



Zinc Mines" (Ron Sloto), and Classic Pegmatite Localities of Connecticut" (Ted Johnson).

During a short but special presentation veteran Delaware County collector, Dr. John D. Hallahan told about having a hole in his shoe as a boy, and tripping over the point of a fine smoky quartz



crystal near the school yard. The audience gasped at the sight of that remarkable specimen, which was the beginning of an eighty year interest in minerals.

After the talks, an auction of books and specimens benefited the Chapter Grant Fund was held, and participants had a chance to look over Chapter books for sale, and specimens available from members, on the giveaway table, and in a silent auction.

On Sunday, participants col-

lected pink dolomite and other minerals at Binkley & Ober Quarry in Lancaster.

The PA. Chapter elected Douglas Rambo president for two years, Arnold Mogel, vice-president for two years, and J. Penrose Ambler as a member of the Chapter Board. John Ebner continues as treasurer, Juliet Reed is the secretary and handles publicity, while Marge Matula is the membership chairman and David Saja edits the quarterly Newsletter, as well the web site.

The Nominating Committee for the Friends of Mineralogy is pleased to submit the following nominations for members of the Board of Directors for the period of 2006-2009:

James F. Hurlbut has been an active volunteer at the Denver Museum of Natural History for 18 years and is well known for his work on the Paul Seel micromount collection. He has many publications on minerals to his credit and has taught a continuing education course on the rocks and minerals of Colorado. Jim is past president of the American Federation of Mineralogical Societies, immediate past treasurer of FM, and a member of many mineralogical and scientific organizations.

Daniel E. Kile, a long-time FM member and past president of the Colorado chapter, recently retired as a geochemist with the U.S. Geological Survey. A well known field collector of Colorado minerals, Dan is now a Scientist Emeritus with the USGS; he teaches optical mineralogy, and coordinates the FM exhibit at the Tucson Show. He was a mid-term appointment to the Board in 2003.

Tony Nikischer is president of Excalibur Mineral Corp, a leading supplier of rare minerals to researchers, museums and private collectors for more than thirty years. He has been a collector since his early youth, and he is also founder and Chairman of the Hudson Institute of Mineralogy, a not for profit research, preservation and educational organization devoted to descriptive mineralogy. He is the owner and publisher of *Mineral News*, and the mineral nikischerite was named in his honor by the International Mineralogical Association in 2001. If elected, this would be Tony's second term serving on the Board of FM.

Dr. Art Soregaroli is a retired geologist who has served in a wide variety of significant positions in the private sector with brief forays into academia and the Geological Survey of Canada. He is still an active consultant to the private sector. Art is a collector and a long-time director of FM and *The Mineralogical Record* and past president of the British Columbia Museum of Mining.

Carol Smith is former president of the Greater Denver Area Gem and Mineral Council. Her interest in minerals dates to 1976, when she met her husband Bill. They have collaborated on a number of magazine articles for *Rocks and Minerals* and *The Mineralogical Record*. She worked in local government as a computer programmer/analyst and has been involved in Democratic politics in Boulder County, Colorado. Carol grows orchids and is addicted to murder mysteries.


