I hope to continue in that mold and make the organization more responsive to the members and to take an active role in the fields of earth science. I am fortunate to have Gloria Staebler continue as our secretary and welcome Julian Gray as our new vice-president. Carol Smith has agreed to take on the newsletter editor position and I look forward to working with her to provide you an informative newsletter. One of the hardest workers on the FM board, Regina Aumente, agreed to continue as treasurer.

I intend to continue many of the initiatives already started and add one or two more a year. These plans always adhere to the objectives of our group as stated on the website:

> FM's objectives are to promote, support, protect and expand the collection of mineral specimens and to further the recognition of the scientific, economic and aesthetic value of minerals and collecting mineral specimens.

an organization should do upon starting the something we all can do to protect mineral job is to "take stock." In light of our objectives, here is what I see:

To Promote...Our members are our best advertisers and advocates. Word of mouth is a powerful tool and one of the most effective, especially at the chapter shows and symposia. The grass roots promotion of mineralogy is accomplished at such programs. In the mineralogical world, our cosponsorship of the TGMS symposium is a very important link with the professional community - one I think we can do even more effectively by becoming more interactive with other societies. We also promote the hobby in our leading magazines, both Rocks & Minerals and Mineralogical Record. done by the good work of Sharleen Harvey our publicity chair.

To Support...We provide support, both financial and logistical, to our members for a variety of projects both local and national. Most local symposia/shows are under the purview of the chapters but we have just started sponsoring other shows in places without a local chapter through the national group. Membership materials have developed by Nelson Shaffer and will be available on the national website. The website serves as one of our more important support tools, please use it for information and to contact the directors.

To Protect... Protection of the hobby from outside forces is problematic. Collecting sites all over the country are closed (private and public) for a variety of reasons. We are looking into ways to keep the membership informed about public lands issues, led by Allan Young. We also need to work with other groups, namely AFMS, who have already established a useful group to monitor and mobilize their constituents on public land issues. Good land stewardship and collecting etiquette go a long way in convincing private owners to let us continue to collect on their property,

collecting.

To Expand...If we do our promotion, support, and protection well, a reasonable expectation is that the expansion of the hobby will take care of itself. Introduction of the hobby to others through shows, symposia, and other educational routes will continue to attract new members since the beauty and scientific fascination of mineralogy sells itself.

To Further the recognition...I believe this is the critical role for our organization. National groups with vibrant memberships have a louder voice than individuals (although we know it is the individuals that do the work). Our affiliation with the American Geological Institute is an important conduit to the geoscience world where we can join with others and affect legislation and policy. I believe we should work with other groups when our interests are similar and I encourage our members to consider joining like societies - we all have similar interests and can benefit from cooperation.

One of the primary responsibilities of any organization is to appreciate its membership. I see myself as the sounding board of this fine group and look forward to your opinions and suggestions. FRIENDS OF MINERALOGY BOARD OF DIRECTORS MEETING FEBRUARY 9TH, 2007 AT INNSUITES HOTEL, TUCSON, AZ

Call to Order – President Bill Dameron called the meeting to order at 7:40 am on February 9, 2007. There were twenty-four board members present out of a possible twenty-six.

Minutes of the Last Meeting – The minutes of the 2006 meeting in Tucson were accepted as recorded in the Summer 2006 newsletter (Vol 36; issue 1).

Treasurer's Report – Treasurer Regina Aumente read the treasurer's report, which was accepted as read. Since the last meeting, Regina sent a member directory to all FM members. The directory contained numerous errors many of which were corrected as a result of feedback from the membership. She noted that the directory is expensive and wondered about the value of publishing it in the future. Regina also requested that she not be the sole signer on the FM bank accounts, nominating Virgil and Carol Smith to become cosigners on the account.

Regina later reviewed the 2007 budget, which was unanimously accepted. She also reminded chapter representatives to get their dues and membership lists into her in a timely manner.

Nominating Committee – Tony read the list of nominees to the FM Board. Each would serve on the Board from 2007 to 2010. Nominated were: Julian Gray, Regina Aumente, Bill Dameron, and Skip Simmons. Gloria reported that the membership returned 35 ballots (2/3 electronically and 1/3 by mail) and all of the nominees were unanimously accepted. The election was certified and accepted by the board.

Tony Nikischer, Art Soregaroli, and Carol Smith were nominated to serve on the nominating committee for 2008. The board unanimously accepted their nominations.

The board nominated Virgil Lueth to serve as President, Julian Gray and Vice President, Regina Aumente as Treasurer and Gloria Staebler as Secretary, all of whom were unanimously accepted by the board.

Awards – Virgil announced the 2006 award winners for best articles:

Rocks & Minerals - Mark Mauthner and Carl Francis for "Gold Crystal Localities of British Columbia, Canada"

The Mineralogical Record - Bruce Cairncross & Uli Bahmann for the "Erongo" issue

extraLapis English - Ross Lillie for "The Great Southern Illinois Fluorspar Deposits"

The best educational case award winners were announced at the TGMS Saturday banquet.

We raised a whopping \$19.00 through sales of the Werner Lieber photos in 2006. Pete Modreski has the photos and tries to distribute them to the other chapters in order to speed up sales.

Publicity – Sharleen is making good use of the FM space in *Rocks & Minerals* and *The Mineralogical Record*, keeping the content rotating and updated.

Newsletter – Carol Smith is the new newsletter editor, taking over for Gloria and hoping to bring the issues out on a more regular schedule. There was a general appeal to all members to opt for an e-newsletter, which saves FM hundreds of dollars each year.

FM Case at Tucson – Bill Dameron and Virgil Lueth volunteered to put together the FM case for Tucson 2008, as Dan Kile will be unavailable.

Website – Jim Etzwiler is doing a nice job with the website. He requested that national own the domain name friendsofmineralogy.org, which is currently owned by one of the chapters. Carol Smith and Skip Simmons are Jim's backups.

Jim is further working on posting the locality indices on the FM website and is in the process of gathering the appropriate permissions from Heldref (Rocks & Minerals), which owns the copyrights for most of them.

Public Lands – Allan Young continues to develop a plan in which FM members can be made aware of changes to specific public land uses. There is a lands group associated with the American Federation and Allan is looking into the effectiveness of that organization and whether we can work with them. He put together a Powerpoint presentation instructing members on accessing government public lands plans in a **qiven** area.

Symposium – Julian Gray reported that five speakers were scheduled to give talks at the symposium this **year**. He has asked Jeff Scovil to do "Best of" talk around the show theme for this and future symposia. Julian is working to line up a full slate of speakers for the 2008 symposium, Mineral Treasures of the United States. Wendell suggested that Julian get the list of exhibits for the 2008

show and consider speakers that would like to talk about the localities not covered.

Locality Index - Art Soregaroli reported that 13 states have not been indexed (mostly in the eastern US) and that four state (Illinois, Montana, Tennessee, and New York) indices are complete and are awaiting publication.

Affiliations – Bill Dameron reported working on an affiliation with the Mineralogical Association of Canada. Nelson Shaffer was not present, but Virgil read Nelson's update which included a reminder that organizations doing anything to commemorate Earth Science Week should provide details to AGI, which will promote the activity.

Pete Modreski had hoped to come up with a mineral-related insert for the AGI teacher-packets, but the project was still in the planning stages.

John Rakovan noted that the MSA outreach committee is developing lesson plans to post on their web site. The kids' portion of the MSA web site currently gets about 2,000,000 hits per year.

Meetings and Socials – As the Clarion will not host a show in 2008, the FM social will move to an as yet undisclosed location. Marty will continue to support the social, providing the refreshments and the space free of charge as he has in years past.

Membership – There was some discussion regarding whether FM should offer a lifetime membership, particularly for those individuals, such as Werner Lieber and Marty Zinn, who support FM with perennial gifts. To offer a lifetime membership, a change would need to made to the bylaws, something Virgil will look into.

Chapters

Pennsylvania held a recent symposium, which went well but could have been better attended.

Pete Modreski reported that the Colorado Chapter is not planning a symposium this year. He noted that the chapter has a number of publications available and is planning a field conference to the Leadville district August 24-26.

A well-organized Tina Tuttle informed the board of the two symposia being hosted by the California chapter. She also reported on two symposia planned for this year, the chapter's work on the Blue Bell mine publication and a project in which members are helping a local museum to catalogue and organize its collection.

Equally well-prepared, Sharleen Harvey read Wes Gannaway's report on the very active Pacific Northwest chapter, which is engaged in supporting educational outreach and the Rice Museum Summerfest fund raiser. The chapter pays \$500 a year for a corporate museum membership, which makes all PNW FM members active members of the museum. Their 2006 field trip and symposium were smashing successes, and the chapter is organizing a program to educate school children about collecting and caring for rocks and minerals.

Other Projects – Virgil requested \$300 to defray printing costs for the New Mexico Mineral Symposium, and his proposal was accepted.

Adjournment - The meeting was adjourned at 9:18 am.

Announces 2007 Distinguished Public Service Medalist

The Mineralogical Society of America Congratulates the 2007 MSA Distinguished Public Service Medalist — Marie Huizing, Managing Editor of *Rocks & Minerals*. The medal is awarded by the MSA Council to individuals who have made important contributions to furthering the vitality of the geological sciences, especially but not necessarily in the fields of mineralogy, geochemistry, petrology, and crystallography. Publication of *Rocks & Minerals* began in 1926. Since 1979 Marie Huizing has made major changes and additions to the magazine that have increased its scientific an educational quality and strengthened its mission of teaching and outreach. But her efforts extend beyond the journal. She travels to many national and international mineral shows each year to promote both the magazine and a wide range of other mineral publications, events, and organizations. She is the hub of an extensive network of both amateurs and professional Mineralogists that she uses for the good of the entire community.

The award has been made more-or-less annually since 1990. Other recent recipients include Daniel E. Appelman (Simthsonian Institution), Dr. George Harlow, (American Museum of Natural History), and Dr. Jeffery Post (Smithsonian Institution).

FM Lands Watch

Over the years and for various reasons, the number of mineral localities open to collecting has seemingly dwindled, and there is growing concern that one of our most treasured outdoor activities may someday become a thing of the past. In the West, many of our favorite collecting localities are on public lands; that is, lands which are managed by the Bureau of Land Management and the U.S. Forest Service, totaling some 450 million acres. Future activities on these lands are largely governed by resource management plans that are periodically updated. Public participation in the planning process is encouraged, and many special interest groups are actively involved in this process on an ongoing basis.

A proposal to establish an "FM Lands Watch" effort at the local chapter level was discussed at the last general meeting in Tucson. Such an effort would involve the identification of proposed Federal management actions that may impact mineral collecting on public lands, possibly using the FM mineral indexes to determine affected sites. This information would then be provided to FM members together with instructions on how to submit comments to the appropriate agency via chapter newsletters and/or special mailings.

Information regarding proposed Federal management actions is available on the internet. It is envisioned that one person from each chapter would be designated "Lands Chairperson" and would be charged with periodically reviewing proposed land management actions in his/her area and reporting back to members.

The American Lands Access Association (ALAA), an organization founded by the American Federation of Mineralogical Societies, has been a successful lobby for promoting the rights of amateur fossil and mineral collectors for many years. The group also represents the interests of recreational prospectors and miners and others using public lands for educational and recreational purposes, and has formed working relationships with many other organizations dedicated to multiple use of public lands. Much of its activities deal with proposed regulations and legislation at the congressional level. As such, the proposed FM Lands Watch effort would not be expected to duplicate, but rather complement, the activities of the ALAA. We welcome your comments.
