

System For Donating Specimens Proposed

Friends of Mineralogy can provide a valuable new service by informing potential donors about minerals being sought by museums, educational institutions, or researchers. We can accomplish this through our newsletter, the FM page in *The Mineralogical Record*, and our web site.

Many FM members have donated specimens or portions of their collections to groups who have legitimate uses for them. Members, and other mineral collectors, are often active volunteers at museums and many of the minerals in museum collections have been donated by such collectors. Rejects from collections have been donated to interest young children in "rock-collecting" or for study by advanced students and faculty. Like most of us, museums and educational institutions have want lists for items needed for specific displays, to upgrade or expand collections, to use as analytical unknowns for students, or for specific research projects.

Our web site will include a "Mineral Wanted" section listing institutions seeking specific minerals. A click on the institution name would connect the viewer to that institution. This would be a fast and relatively simple method of disseminating want lists and alerting members about opportunities to assist worthy works. For collectors who are not computer literate part of our newsletter and even a part of the page in *The Mineralogical Record* could help to disseminate the information.

To make such a project a success, the participating institutions would have to maintain complete, up-to-date want lists and should be ready to properly acknowledge gifts received. Donors should realize that gifts would have no conditions; samples could be displayed, sold, traded or even ground to dust for analysis.

Status of the State Mineral Locality Index Project

FM's Locality Index Project is to prepare and ultimately combine and publish in one volume an index of the most significant mineral localities in each state of the U.S. (and thereafter, the rest of the world). Below is an updated list of all the states presently completed and published since 1979 (20 total; 18 in Rocks and Minerals, 2 in The Mineralogical Record), plus those states for which indices are presently in review or in varying stages of preparation. Some 13 states are not yet in progress. In the near future, Jim Hurlbut and I will be contacting all those people who have work in progress or who have tentatively offered to work on particular states, as well as FM chapters or others who may be willing to work on some of the remaining states. 
Pacific Northwest

1. At the March 7 meeting: Western Washington University Geology Department. Staff geologist George Mustoe, host, led a participative learning experience:

"Reconstructing the Geologic History of Washington." Following the meeting the x-ray diffractometer was demonstrated and members used the photomicrographic equipment.

- 2. The June 6 meeting was at the Rice Northwest Museum of Rocks and Minerals. Very fine specimen displays including the fine sperrylite specimen from the cover of the March-April issue of *The Mineralogical Record*.
- 3. In late June the Chapter will collect in Utah. The trip will start on June 22 at the visitor's center in Wendover, Utah. Sites: Gold Hill, Topaz Mtn. and the Tintic District.




